FLORIDA BAR APPLICATION: The Florida Board of Bar Examiners considers timely amendments those that are filed within 30 days of the occurrence triggering the amendment (transferring from one law school to another). We urge you to file your amendment within the first week of classes. The amendment form is found here.

- 4. OFFICIAL TRANSCRIPTS: Students must submit to FIU Law and LSAC official transcripts from their degree-granting institutions (undergraduate and graduate), showing the date(s) of degree conferral and the degree conferred. Transfer students must also provide official transcripts from all previous law schools where they were enrolled. If your previous institution provides official transcripts via electronic means, please have transcripts emailed to <a href="mailto:lawadmit@fiu.edu">lawadmit@fiu.edu</a>. 5. IMMUNIZATION: In order to register for classes your immunization records must be on file. If you do not provide proper documentation, you will not be able to register and

will continue to have an immunization hold on your account. The document must be signed by a physician (M.D. or D.O.), a nurse practitioner, or a registered nurse, and mailed, sent via fax 305.348.3336, or physically brought to the FIU Student Health Services Office (Modesto Maidique Campus), by **July 3, 2014**. Calls from your physician are **not** acceptable.

- 7. REGISTRATION, TUITION AND BILLING: 1L students are registered automatically by no later than August 1, 2014. You will receive an email when your registration is complete. FIU Law <u>does not</u> mail tuition or billing information. Once you are registered, your charges will be automatically reflected in the Student Financials area of MyFIU. The tuition payment deadline is August 15, 2014.
