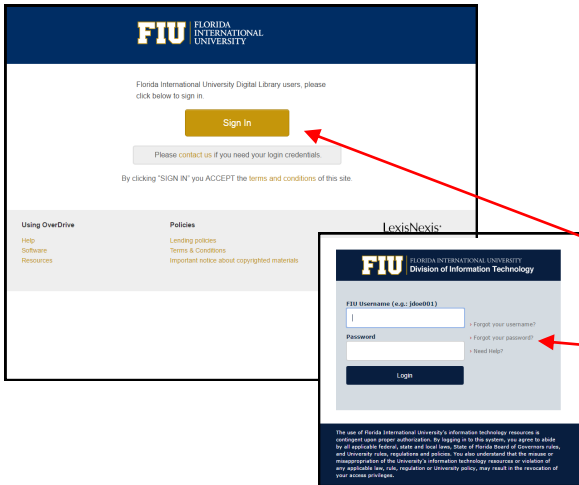


Follow the steps below to borrow and read an eBook from the LexisNexis® Digital Library to your desktop, laptop or portable device. For most digital library eBooks, choose from three platforms—OverDrive Read™ (in-browser reading), ePub or Kindle® (read on your e-reader device or app). To access full functionality of the LexisNexis® Digital Library site, you will need to have one of the following browsers installed: Internet Explorer® 10 (or higher), Google Chrome™, Apple® Safari® or Mozilla Firefox®.

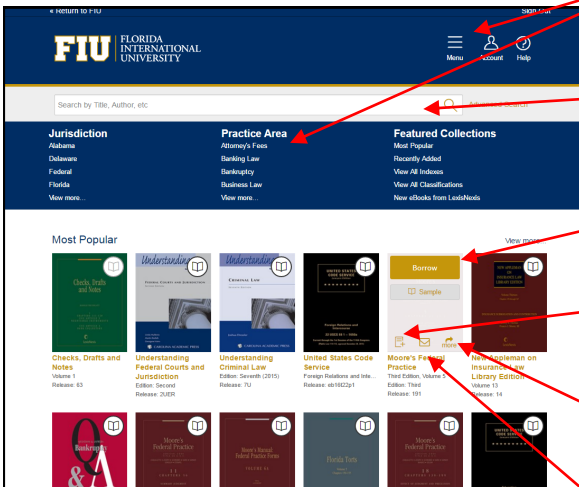


1. Sign-on page. Locate the LexisNexis Digital Library page and sign in with your school’s credentials.

If you are on the FIU network, click “Sign In” to access the site.

When off network you are prompted for your network FIU user name and password.



2. Main page. Clicking the **Menu** function will display a dropdown of categories by jurisdiction, practice area, and featured collections.

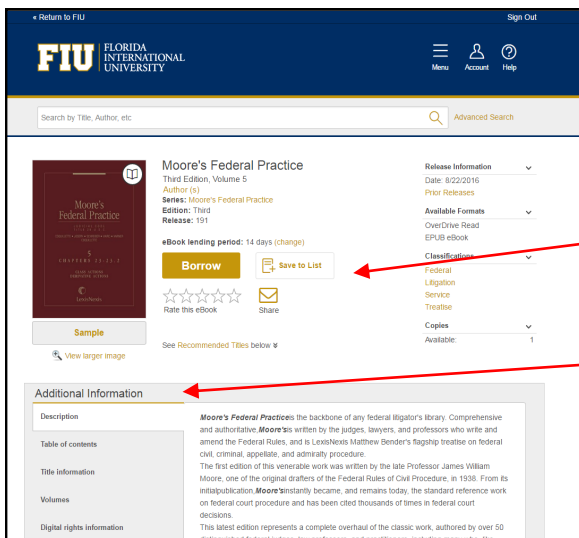
Search by title name, author, subject or keyword; or use the Advanced Search template. Browse the content listing and select a publication using the Menu dropdown.

Hover and click the **Borrow** button to place the volume in your Checkouts.

Click **Save to List** icon to place the title in your bookshelf list and **More** icon return later to borrow it. Use this feature to easily locate titles you use most often.

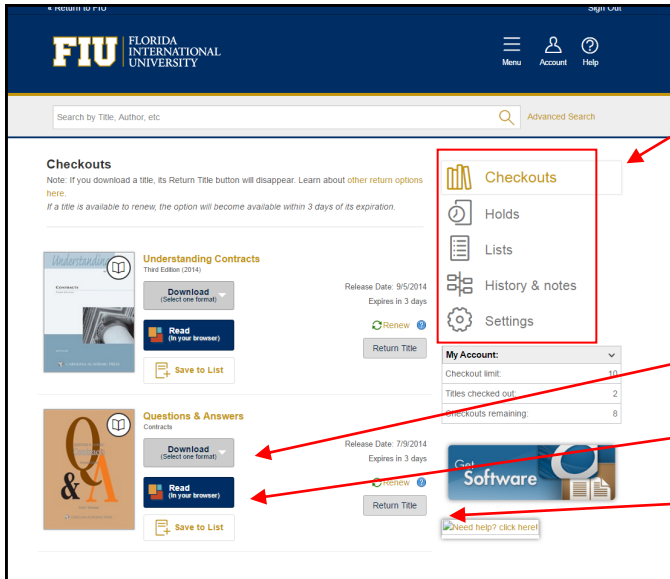
Click the **More** icon to go to the Detail page for information about the eBook.

Click the **Share** icon to send a link for the eBook to a colleague to borrow the eBook.



3. Book detail page. Information about the eBook is available on the Detail page. Borrow, Save to List or Share from this page.

Use the Additional Information section to review the Table of Contents or additional volumes in a multiple volume set.



4. Account Page. The Account Page lists your Checkouts, Holds, List of saved eBooks and History & notes from eBooks previously borrowed.

Reading options may vary based on your organization's e-reading software decisions. For most digital libraries, three options are available: Amazon® Kindle®, ePub or OverDrive® Read™.

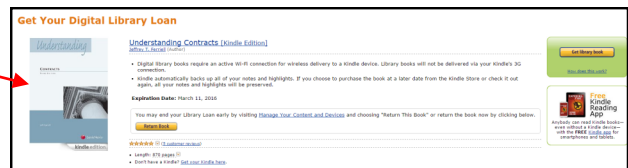
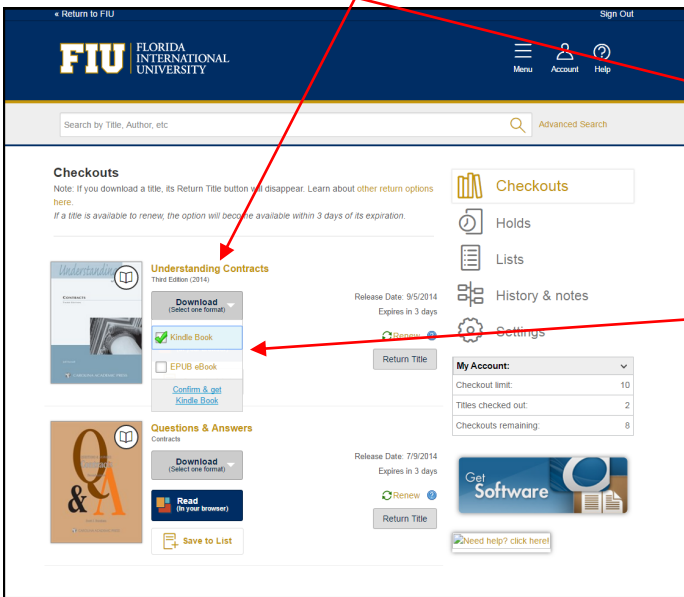
Click Download to obtain a Kindle® (if available) or ePub version.

Clicking the Read button launches OverDrive® Read™ to read in your Web browser.

Click the Return Title button to remove the book from Checkouts on the Account Page.

Downloading eBooks for Kindle

Click on the Download selection to display available options. *If a Kindle version is available it will display as a choice.* Click **Kindle Book** to borrow from your digital library via Amazon®. An active Amazon account is required for individual users.



Downloading eBooks for ePub e-readers

Click **ePub eBook** to borrow from your digital library to read on your installed e-reader. Then click **Confirm & Download**. Your eBook will launch in the e-reader.

Note: Install your e-reader prior to downloading. Adobe® Digital Editions is popular for desktop/laptop reading for both PC and Mac®. An active Adobe ID is required via a quick registration as part of the installation process.
