#### LAW TEACHING AND ADMINISTRATIVE RESPONSIBILITIES

My broad teaching experience reflects my research interests, my prior experience as a litigator, and my willingness to accommodate the curricular needs of my institution. Relatively traditional in terms of the Socratic method, I use interaction in the classroom to hone students' analytical skills and to emphasize the ethical dimensions of legal practice. Informed by my

experience in critical jurisprudential movements, I integrate theoretical perspectives into my doctrinal courses as appropriate and develop theoretical perspective more fully in my seminars.

**COURSES TAUGHT:** Contracts I and II, Remedies, Torts I and II, Products Liability, Corporations, Remedies, International Law, Administrative Law, Business Organizations, Agency and Partnership, Law and Accounting, Antitrust, Securities Regulation, Comparative Corporate Law, Citizenship and Immigration Law, Race and the Law, Professional Responsibility, and Street Law.

**ADMINISTRATION:** In addition to serving as associate dean (the academic officer of the law school), I supervised the law school ABA accreditation application, rewrote the law school's governing document—its bylaws, initiated the law school's mentoring program (both processes were recognized by the ABA site inspection team), chaired every major committee at the law school. Also served key roles in several university committees, including the faculty senate, the faculty senate's executive committee, and the executive committee's budget committee. Played significant roles on university committees during budget crisis, and part of core team making critical decisions concerning school closings and reorganization. Reviewed university budget, budget projections and deliberated on key recommendations concerning future budget cuts and program adjustments. Prior to joining FIU, served on key committees while at St. University Law School, including chairing the curriculum committee during my first year after attaining tenure. Also served for six years as the only untenured STU's law school faculty member on the promotion and tenure committee.

#### SCHOLARSHIP

---

My principal research interest involves analyzing the construction and interpretation of the law of citizenship, as a specific instance of wider themes about social inclusion, hegemony, economics, and race. My scholarship may be best described as traditional in its structure and use of authority, but critical in its perspective. Necessarily my research deals with the intersection of, on the one hand, citizenship law, immigration law, public international law, and constitutional law and, on the other hand, theoretical perspectives based on critical race theory, post-colonial studies, Diaspora literature, and social theory generally. Given the increasing domestic and global relevance of citizenship and nationality in the United States and globally, I expect to deepen and expand my work on citizenship.

## SERVICE

Forming part of a new law school's founding faculty has provided me exceptional opportunities for service. One of the fundamental objectives of my service activities is to institutionalize a culture of scholarly production, especially among my junior colleagues. To this end, I have instituted a mentoring program for junior faculty and strengthened our faculty colloquium series. Another important personal and professional commitment of mine is to increase the representation of traditionally disenfranchised minorities in both the legal profession and higher education. Perhaps my greatest achievement is my fairly recent ability to apply my theoretical beliefs and convictions in a manner that may affect local and national communities. Among my efforts on this front is my work with the organizations: Students Working for Equal Rights (SWER), DREAM University, as well as acting as an advocate for several dreamer law grads seeking to be admitted to their respective state's bars. My service commitment has gone well beyond our borders, and has included among other things, being the first domestic writer to address the statelessness issue in the Dominican Republic, and have more recently served as a legal advisor for groups challenging the Trump administration's Muslim ban.
