### **INTRODUCTION**

  assigned or necessary supplemental materials for complete and successful understanding of legal
  principles; seeking Technology Fee funding to support these acquisitions; and
- **Learning Resources**: Purchasing legal education learning resources assigned by Academic Excellence Program in support of Bar Preparation and learning success.

In 2018-2019, two hundred and forty-eight (248) study aid titles, including the Understanding, Questions & Answers, and Mastering Series, were checked out 2,940 times by law students, resulting in an estimated value of \$69,072.00.
